SUMMARY NOTICE OF PENDENCY OF CLASS ACTION

This Notice concerns a securities class action currently pending which may affect your legal rights. Please read it carefully. This Notice was authorized by the United States District Court for the Western District of Washington.

To: (1) All persons or entities who purchased or otherwise acquired Zillow Group, Inc. (“Zillow”) Class A common stock or Class C capital stock during the period from August 5, 2021, to November 2, 2021, inclusive (the “Class Period”), and were damaged thereby.

YOU ARE NOTIFIED that, by an Order of the United States District Court for the Western District of Washington, this case has been certified as a class action.

The Class Representative alleges that Defendants violated federal securities laws by issuing materially false and misleading statements concerning Zillow’s initiatives to increase the home purchasing volume of its iBuying business, Zillow Offers. Defendants have denied and continue to deny each and every allegation and that that they caused any damages to the Class. At this time, there is no judgment, settlement, or monetary recovery.

IF YOU ARE A MEMBER OF THE CLASS, YOUR RIGHTS WILL BE AFFECTED BY THIS ACTION. This is only a summary of matters regarding the litigation. THIS NOTICE IS NOT AN EXPRESSION OF ANY OPINION BY THE COURT AS TO THE MERITS OF ANY CLAIMS OR DEFENSES ASSERTED BY EITHER SIDE IN THIS CASE. THE SOLE PURPOSE OF THIS NOTICE IS TO INFORM YOU OF THE LITIGATION SO THAT YOU CAN MAKE AN INFORMED DECISION AS TO WHETHER YOU SHOULD REMAIN A CLASS MEMBER OR OPT OUT OF THIS CLASS ACTION.

If you are a Class Member, you have the right to decide whether to remain a member of the Class. If you choose to remain a member of the Class, you do not need to do anything at this time other than to retain your documentation reflecting your transactions and holdings in Zillow Class A common stock and/or Class C capital stock during the Class Period. You will be represented by Class Counsel appointed by the Court unless you retain your own counsel at your own expense and your counsel enters an appearance on your behalf by September 15, 2026. Regardless of whether you appear by your own counsel, if you are a Class Member and do not exclude yourself from the Class, you will be bound by the proceedings in this Action, including all orders and judgments of the Court, whether favorable or unfavorable.

If you ask to be excluded from the Class, you will not be bound by any order or judgment the Court may enter in this Action, and ***you will not be eligible to receive a share of any money which might be recovered for the benefit of the Class***. To exclude yourself from the Class, you must submit a written request for exclusion postmarked no later than August 31, 2026, to the Notice Administrator in accordance with the instructions set forth in the full, more detailed Notice.

To ensure that you receive all future notices in this Action, you are requested to register your name and contact information with the Notice Administrator at www.JaegervZillowLitigation.com. If the Notice Administrator does not have your correct contact information, you may not receive any future notices that may be disseminated in this Action. You do not need to register if you are excluding yourself from the Class.
